2. Recipients of a grant are not guaranteed entry into any SCPGA Junior Tour event. Grant recipients must register for events in the same manner of any Junior Tour member.
3. Grants are only to be used for SCPGA Junior Tour membership and/or tournament entries, and must be used only for the calendar year the grant is awarded.
